# CLERY ACT DEFINITIONS

## CLERY ACT CRIMES

### Homicide

• The intentional or negligent killing of another person.  
• The death of a person as a result of a violent crime.  
• The death of a person as a result of a crime involving the use of a firearm.  
• The death of a person as a result of a crime involving the use of a knife or other sharp object.  
• The death of a person as a result of a crime involving the use of a vehicle.  
• The death of a person as a result of a crime involving the use of a weapon.

---

### Sex Offenses

• Any offense involving sexual contact or sexual intercourse with another person.  
• Any offense involving the use of force or coercion to obtain sexual contact or sexual intercourse.  
• Any offense involving the use of a weapon or dangerous instrument in the commission of a sexual offense.  
• Any offense involving the use of a vehicle in the commission of a sexual offense.  
• Any offense involving the use of a computer or other electronic device in the commission of a sexual offense.

# CLERY ACT DEFINITIONS

## Domestic Violence

Domestic violence is a pattern of behavior that includes but is not limited to: physical, sexual, psychological, or emotional abuse by a current or former intimate partner, family member, or household member. This includes acts such as: hitting, slapping, or pushing; threatening or intimidating; stalking; and controlling or isolating the victim.

## Stalking

Stalking is a course of conduct, including but not limited to: repeated, unwanted communications or contact; following or monitoring the victim; or threatening the victim, that causes the victim to feel fear or distress.

## Liquor Law Violation

Liquor law violation is a violation of any state or local law, ordinance, or regulation relating to the possession, sale, or consumption of alcoholic beverages.

## Drug Law Violation

Drug law violation is a violation of any state or local law, ordinance, or regulation relating to the possession, sale, or consumption of controlled substances.

## Illegal Weapons Possession

Illegal weapons possession is the possession of a firearm or other dangerous weapon in a prohibited location, such as a school, public place, or workplace.

## Larceny-theft

Larceny-theft is the unlawful taking of another person's property with the intent to permanently deprive the owner of the property.

## Simple Assault

Simple assault is an attempt to cause physical injury to another person, or the use of force or violence against another person, without the intent to cause serious or substantial harm.

## Intimidation

Intimidation is the threat of physical injury to another person, or the use of force or violence against another person, with the intent to cause fear or distress.

## Destruction/damage/vandalism of property

Destruction/damage/vandalism of property is the intentional or negligent destruction, damage, or defacement of another person's property.

# CLERY ACT DEFINITIONS

## CLERY ACT GEOGRAPHY

### On Campus

- ▶ **On Campus** means any building or property owned or controlled by an institution of higher education, whether the building or property is located on the institution's campus, on property under the institution's jurisdiction, or off campus.
- ▶ **On Campus** does not include any building or property owned or controlled by an institution of higher education that is used for the primary purpose of housing students, including any building or property used for the primary purpose of housing students who are employed by the institution of higher education.

### Noncampus Building or Property

- ▶ **Noncampus Building or Property** means any building or property owned or controlled by an institution of higher education that is not located on the institution's campus, on property under the institution's jurisdiction, or off campus.
- ▶ **Noncampus Building or Property** does not include any building or property owned or controlled by an institution of higher education that is used for the primary purpose of housing students, including any building or property used for the primary purpose of housing students who are employed by the institution of higher education.

### Public Property

- ▶ **Public Property** means any building or property owned or controlled by a state or local government, or any building or property owned or controlled by a private entity that is used for the primary purpose of housing students, including any building or property used for the primary purpose of housing students who are employed by the institution of higher education.
